During the Lame Duck Session, NAHRO held an Advocacy campaign. NAHRO set a lofty goal to send 3,400 letters during the session and crushed this goal by sending out 4,240 letters to Congress. NCRC sent 590 of these letters! Congratulations to Michigan NAHRO for leading NCRC by sending 159 letters to Congress.

The "Advocacy for the Busy Professional" presentation continues to travel to each state conference. We have presented in Iowa, Indiana, Ohio and Illinois. I presented the "Advocacy for the Busy Professional" with Tess Hembre and Mike Gerber on October 25 at the National NAHRO Conference in Atlanta. I am working with National NAHRO on a "Train the Trainer" program that will be launched in all 50 states. I am incredibly proud that this work was generated out of our great region.

Elections for officers will be held in April 2019. The positions that will be available on the ballot include: President, Senior Vice President,

Secretary, Treasurer, Vice President of Housing, Vice President of Community Revitalization and Development, Vice President of Member Services, Vice President of Commissioners, Vice President of International and Global Exchange and Vice President of Professional Development. The objectives of the retreat aligned with our principle of Developing Leaders. NCRC Board members spent the day exploring why a "growth mind-set culture" is critical in today's work environment and learning about talent mobility and how it can help mitigate risk from unexpected vacancies or critical skill gaps by creating a safety net

for the organization.

The NCRC Executive Board had an incredibly productive meeting on Friday, January 11. The Board reviewed 2018 accomplishments, reported out on goals for 2019 and spent over an hour discussing the impacts of the federal government shut down and creating an Agency Engagement Plan for NCRC members.

During our time in Chicago, a few NCRC board members met with Lisa Lee, Executive Director of the National Public Housing Museum and Eugene Jones, CEO of the Chicago Housing Authority to begin planning and identifying partnerships for the 2020 conference.

Senior Vice President Report

Greetings Officers and Members of NCRC of NAHRO,

I am proud of what NCRC has accomplished over the past year and I look forward to 2019.

The State Association of Indiana led the planning, coordination and hosting of the NCRC annual conference that was held in Fort Wayne, Indiana on April 30-May 2, 2018. NCRC 2018 was composed of 160 attendees, 45 vendors and 53 speakers. Our phenomenal speakers were Keynote Speaker Carl Ritchie, NAHRO President, Adrianne Todman, NAHRO CEO, Joseph Galvan, Housing Urban Development Region 5 Director, Unabyrd Wadhams, Deputy Assistant Secretary for Field Operations and Kimberley Toler, Assistant Regional Inspector for Region 5.

I took a field trip to attend the Texas Housing Agency conference to facilitate a session on Leadership: How to build a Team to Overcome Obstacles.

I met with the various Task Force Chairs to discuss their Agenda for 2018-2019. Each Task Force indicated that they are progressing and moving forward with the current leadership team. More details were presented in the past reports.

However, we continue with the challenge of active participation of the volunteers. At the same time, I am encouraging volunteers to support the task force efforts. We have continuously highlighted the importance of engagement of the volunteers. We have stressed the importance as a vital component of our organization.

There is ongoing conversations with Jim Dewey in a plan to assist states in our region, with the development of a state-by-state legislative plan. There are states in our region that do not have a Housing/Legislative representative. This makes it difficult to advocate. Therefore, we will combine our resources and will continue to pursue ways to assist those states in building the capacity to do so.

I also attended the Board of Governors Retreat in

Austin, Texas.

I had the opportunity to attend the Summer NAHRO Conference in San Francisco.

- The conference held over 600 attendees. The documentary screen of 70 acres in Chicago: Cabrini Green was well attended.
- o It received very good reviews from peers.
- I also had the opportunity to facilitate two sessions, Succession Planning: Talent Mobility, Housing, and Education: No Cost/Low Cost Education Strategies.

In addition, my schedule for 2019 includes my attendance at every state conference in 2019. I look forward to visiting each state and in some cases being available to present on topics of interest, if requested.

It is important for us to take notice that it appears that our voices was heard on the hill:

- HUD will be rescinding the Annual Contributions Contract (ACC) (Form HUD-53012, OMB Approval No. 2577-0075) that took effect in May of this year.
- HUD to Delay Implementation of the FSS Performance Measurement System
- I will be submitting to the membership information on a new the *Task Force on the Impact of the Affordable Housing Crisis* Indiana Senator Todd Young has co-founded. He and others are attempting to build a coalition to engage and legislate. I introduced Tess to Senator Young's staffers at the request of the Senator. The Task Force is seeking the support of agencies.

I will be wrapping up the final year of my role as NCRC Senior Vice President. However, I would like to pursue the opportunity to be a candidate for the office of President the ensuing year. Nevertheless, I am dedicated to and supportive of our president and our membership as we go forth in 2019. I will continue my commitment to continue developing and supporting agencies and others as needed.

Housing Committee

As we are all well aware, the partial government shutdown that began on December 22nd has continued into the new year as Congressional leadership and the White House are at a standstill over funding border security. HUD payments for Public Housing

and Section 8 were disbursed for the month of January and are expected to be available in February. As we anxiously await reopening of the federal government, please be on the lookout for additional information from NAHRO as they have been instrumental in keeping members updated via email, website and social media.

Despite the current status of government shutdown, NAHRO members should be commended for exceeding the goal of sending 3,400 advocacy letters to Congress during the lame duck session. Over 3,700 letters were sent to Congress urging them to finalize FY2019 and approve the Affordable Housing Tax Credit Improvement Act. Advocacy plays a huge role in our industry, and we look forward to taking this process a step further during the 2019 Washington Conference on April 7-9, 2019. Ongoing discussions have taken place amongst many NAHRO Committee members and State Chapters since the last conference in Washington regarding ways to effectively communicate to members of Congress. We are eager to put our plans into action during the upcoming legislative conference and see significant results in 2019!

Professional Development Committee

Small Agency Task Force

Greetings NCRC Board Members,

Reflecting on 2018, I'm reminded of the importance of this small but mighty group at all levels of NAHRO. The

value that is received from our National level is insurmountable © With CEO Adrianne Todman at the helm, there is a high level of expectation from staff, committees and members of NAHRO to research, prepare, take action, learn and evaluate each step.

Right before Christmas break, NAHRO held a conference call for the NAHRO SATF committee in anticipation of the government shutdown and what to expect if/when it happens. The information was forwarded to all NCRC SATF committee members as well as I forwarded it at the State level. Even though the shutdown seemed imminent, it was somewhat a relief to know that our January 19' funding would be available. Now to be concerned with ongoing funding is unknown.............

FAST-FORWARD to today.....25 days later and the government is still shutdown with no end in sight.

NAHRO staff have been working diligently to funnel information through every channel to keep housing authorities abreast of any information that would be indicative of the Congress's position to open the government back up. NAHRO will be creating verbiage for housing authorities to utilize in communicating with our boards, landlords, media, etc.

NAHRO has created a survey to quantify the impact of the shutdown. Please click on this link <u>NAHRO Shutdown</u> <u>Survey</u> to complete the survey.

The following was received from HUD's Office of Public and Indian Housing:

"In accordance with HUD's contingency plan, the Office of

Public and Indian Housing (PIH) will allow access to your HHR funds in situations where the failure to act "would result in an imminent threat to the safety of human life or the protection of property." PHAs may request their HAP reserves from HUD under the following circumstances:

- 1. To protect families that are at imminent risk of termination of assistance; and/or
- PHAs that were eligible to receive a payment for January 2019 and did not receive it (e.g., first time RAD payments for a project) and need reserves to ensure that the property owner(s) receive(s) a HAP payment to continue assistance and protect the residents at the property.

Please note that these reserve funds may not be used for any other purpose than HAP funding.

In order to request an additional payment covered by the HHR, please contact Robert Boepple, Director of the Financial Management Center (FMC) at Robert.H.Boepple@hud.gov. The request should include the amount of additional payment, supporting monthly leasing projections, as well as a point of contact email and phone number. The PHA must also detail any cost savings measures that have been taken to date as outlined in PIH Notice 2011-28 to decrease the possibility of a shortfall.

PHAs should also review PIH Notice 2013-28 Guidance on the Use of Outside Sources of Funds in the HCV Program, to ensure proper adherence to the requirements of this Notice."

Legislative Report

All we got for Christmas was a government shutdown! No that's not how the song is supposed to go, but on December 21st, the government did have a partial shutdown and HUD was included in that shutdown. In total, 9 of the 15 government departments were

shut down. As of the writing if this report the shutdown continues with no end in sight. On the bright side, January and February HAP and Operating Fund payments were put in the system before the shutdown, so they will be available for drawdown.

For minute-by-minute information on what is going on, follow NAHRO on Twitter at MAHROnational and NAHRO's Director of Congressional Relations Tess Hembree at MAHRO IS CONTINUING TO SUPPLY INFORMATION TO SUPPLY IN

How did this happen? On Monday, December 17th, we had hopes that a CR budget deal would be done. By Wednesday evening it was looking more like a CR was going to be the answer to keep the government open, but by Thursday the situa-

tion dissolved quickly when the President made it clear he was not signing a CR unless he got his 5 Billion for the wall. On Friday, the initial CR expired without a budget deal or another CR in place. Congress is back, but a deal is not in sight yet.

For the good news, NAHRO members stood up and took the December advocacy to heart by smashing our enthusiastic goal of 3,400 letters by sending over 4,200 letters to members of Congress. Thank you to all who participated, it was a challenge, but we did it and surpassed the goal! Congrats to you all, but we need to keep the pressure up to make sure that the decision-makers in Washington know that a functional government is needed to properly run our programs and provide safe, decent, and affordable housing.

Remember, there is still time to encourage your legislators to join the Public Housing Caucus. NAHRO has a pre-canned letter for you to send, if you so choose, in the advocacy center. You can also find out more about what a congressional caucus is and how it works and why it's important for public housing to have strong support by visiting the NAHRO Advocacy Action Center.

Our NCRC Legislative Task force has drafted this year's Legislative Position Paper for our region. It was discussed further in Chicago and the final will be available for distribution by January 31st.

Community Revitalization & Development Report (CR&D)

Happy New Year! First and foremost, thanks for electing me as your CR&D representative during the Atlanta

NAHRO conference. While this role is still new to me, I am no stranger to community and real estate initiatives. For the purposes of reporting out the NCRC Officers, this report is being prepared in the following structure:

- 1. Update on HUD and related redevelopment initiatives
- 2. Training/Announcements
- 3. Committee work

HUD Initiatives – Rental Assistance Demonstration (RAD) Program

By now many PHAs are engaged in new development or redevelopment with either RAD, LIHTC, PBV or a combination of same. The most recent updates from HUD on the RAD side were provided via the HUD RAD Resource Desk. The update allows users to more easily manage their RAD transactions and more efficient processing of RAD transactions through improved site navigation, and easier access to information. Key features of the refreshed site include guicker navigation to various aspects of the RAD transaction, web-based application for all RAD transactions, single logon ids for users that now require multiple accounts and landing pages that have been broken into sub-categories, allowing users to close and/or relocate cards on their page to customize their home page. Also, some documents and information that previously required logins are now available from the public screens. HUD now has Resource Desk training available to sub-groups. This update was provided during the last quarter of 2018. Opportunity Zone

The National Council of State Housing Agencies published an online "Opportunity Zone Fund Directory," which is a compilation of Opportunity Zone fund opportunities. These resources provide descriptions and contact information for public-announced funds that have been formed for the purpose of attracting

investment in Opportunity Zones. NCDHS is track-

ing only multi-project opportunity funds at this time. NCSHA will update the directly regularly and invites funds to submit deals for inclusion. Jim Tassos is the point of contact for more information.

Local HUD Partnership -Support -Engagement 2018 IN NAHRO Executive Directors (17) met with newly appointed local HUD Director and Team to discuss 2018 Budget, Small Housing Authorities and HUD semi-annual trainings to prepare and prevent OIG and QAD Reviews.

IN NAHRO Hosted 2018 NCRC NAHRO Conference The State Association of Indiana led the planning, coordination and hosting of the NCRC annual conference that was held in Fort Wayne, Indiana on April 30-May 2, 2018. NCRC 2018 was composed of 160 attendees, 45 vendors and 53 speakers. Our phenomenal speakers were Keynote Speaker Carl Ritchie, NAHRO President, Adrianne Todman, NAHRO CEO, Joseph Galvan, Housing Urban Development Region 5 Director, Unabyrd Wadhams, Deputy Assistant Secretary for Field Operations and Kimberley Toler, Assistant Regional Inspector for Region 5.

"NCRC NAHRO 2018 Conference "Working Together For A Better Tomorrow." The conference was held in downtown Fort Wayne, Indiana at the Grand Wayne Convention Center. The regional conference featured relevant learning sessions, a variety of challenging and engaging speakers, to include 45 national, state and local vendors including community partners, a Fort Wayne TinCaps (Midwest League) baseball game, networking opportunities, and much much more."

In March NAHRO Executive Directors Met with the Senator Todd Young in Washington, D.C.

Again, I will be submitting to the membership information on a new the Task Force on the Impact of the Affordable Housing Crisis Indiana Senator Todd Young has co-founded. He and others are attempting to build a coalition to engage and legislate where necessary on issues of Affordable Housing. I introduced Tess to Senator Young's staffers at the request of the Senator. The Task Force is seeking the support of NAHRO. Indiana NAHRO will continue to meet with the Senator moving forward to assist him and his staff in tackling affordable housing issues on a local and national level.

• In 2018 IN NAHRO Board identified the need for more engagement from our State and Federal legislators in the area of affordable housing, legislative and advocacy. As a result we decided to begin the work to establish a white paper to assist them in this effort. Since then we have engaged Purdue personnel to assist in creating the white paper. We look to establish 3-5 items to focus on 2019.

Here are some of the issues we are surveying PHAs throughout the State:

- Help communities address blight, end homelessness, and provide homes within reach.
- Expand permanent supportive housing for the homeless and special needs populations; Keep the homeless, elderly, and disabled populations stably housed, in their own homes, and out of institutions.
- Increase neighborhood assistance programs to help the most vulnerable people.
- Help counties expand the availability of affordable homes (this may be more state focused).
- Enable more local tax abatement for mixed-use development. (this may be more state focused).
- Establish fast track foreclosure for vacant properties. (this may be more state focused).
- Provide resources for creating pathways to self-

sufficiency. Transition from home renters to home buyer.

- Continue Advocacy for Small PHAs
- Collaborative training with HUD on VMS and the 2 Year Tool

We have been working with our Local HUD office new PH Director, Catherine Lamberg, on addressing local challenges and opportunities. We will continue to have regular trainings/meetings in an effort to encourage engagement and partnership on appropriate matters.

VMS Training will be presented by Mr. David Zaiser, Financial Analyst/Team Leader, Office of Public Housing, Jacksonville, FL. There were 60+ participants from Indiana Housing Authorities.

Headline: Senator Todd Young Visits Fort Wayne Housing Authority, Fort Wayne, IN to speak with the community leaders about impact of affordable housing to assist his legislation in Washington, D.C.

We are assisting Senator Todd Young's and his colleague Task Force on the Impact of the Affordable Housing Crisis Act. We plan to provide more information to the region on this task force as they are encouraging us to encourage our peers support of the initiatives.

Iowa NAHRO sponsored a <u>S.A.V.E Yourself Training & Conflict</u> <u>Resolution/Verbal De-escalation</u> training in October, 2018. The training was well attended and many learned valuable skills to

deal with difficult people and how to handle a very dangerous situation when confronted with a possible shooter.

The Iowa NAHRO Annual Conference will be held May 16th & 17th in West Des Moines. The Professional Development committee is hard at work putting together training sessions.

Portability... The State of Iowa has been dealing with the portability issue for quite some time. Many Pubic Housing Authorities are losing the ability to assist the maximum number of families in their service areas because of high portability expenses. This also causes PHAs to experience sharp decreases in administrative fees that have already been cut. Iowa has been experiencing a lot of "voucher shopping" as

recipients fulfill their first-year lease, then move out of the PHA's jurisdiction. When the other PHA bills for the voucher, it can be very costly to the Iowa PHA. This action reduces the PHAs ability to serve its own population.

Much discussion regarding this issue has been had with Senator Ernst, Senator Grassley and Congressman King's offices. Most recently, a letter from Congressman King was sent to HUD Secretary Ben Carson about how portability is affecting the State of Iowa. His office has requested information on the following:

- 1) Whether the Department is considering discontinuation of the portability option?
- 2) Whether the Department is considering requiring funds that are allocated to a community PHA to remain in that jurisdiction?
- 3) Whether the Department has exceptions for states and localities that are harmed by "portability"? Specifically, is the Department considering regulation that would eliminate voucher shopping?

We are having discussions with PHA's from other states who are having similar portability issues as lowa. We are working together to make our voices heard!

As I write this article, the Federal Government Shutdown enters its second month and is the longest on record. Minnesota NAHRO is working to sup-

port and educate our members and keep them abreast of the latest developments in the following ways:

 On January 18th MN NAHRO hosted a statewide conference call for our members to discuss the current status of the shutdown, the impact on our programs, what agencies in Minnesota are doing to minimize the impact on residents and resources available. Tess Hembree, Director of Congressional Relations for NAHRO; Jennifer Keogh, NCRC President; Barbara Dacy, Legislative Chair for MN NAHRO, and myself conducted the call and fielded questions from our members. We intend to continue these calls, with the next call scheduled for February 1st, until the shutdown ends.

- We have added a page to our website to post resources and updates as they become available.
- Weekly Action Alerts are being released with the latest information and reminding our members to contact their lawmakers and the White House about the impact of the on-going shutdown.

As our members grapple with the effects of the Federal Government Shut-down, we continue to work on state-wide legislative issues including a bold ask of \$300 million in bonding for housing initiatives.

The Minnesota NAHRO Board adopted our 2019 State Legislative Priorities including:

- Seeking an increase of \$55 million in appropriations for affordable housing
- Seeking \$100 million for GO Bonds for Public Housing Rehabilitation
- Seeking \$200 million for Housing Infrastructure Bonds to develop permanent supportive housing and affordable senior housing
- Supporting continued appropriations for local redevelopment tools and programs (DEED, establishment of a State Tax Credit Contribution Fund)
- Seeking an increase of \$25 million in appropriations for investments in several DHS housing programs that include support services to address homelessness in Minnesota

The Board, through its legislative committee, have also been working on several initiatives:

- Submitting a comment letter on the Affirmatively Furthering Fair Housing proposed rule
- Continuing to monitor the progress on "Prosperity's Front Door" campaign which is a direct result of the Governor's Task Force on Affordable Housing
- Participated in NAHRO's Lame Duck Advocacy Campaign
- Finalized the "Small Agency Tool Kit: A Step By Step Guide to Advocacy" to be distributed to our membership

 Participated in the Homes For All Policy agenda process to determine what issues Minnesota NAHRO wants to lead, support, and/or monitor

In anticipation of the significant GO Bonding request for Public Housing Rehabilitation, the MN NAHRO Board authorized the hiring of a consultant to perform a **Public Housing Capital Needs Assessment Survey** to determine the current unmet capital investment need across the state. We will use the results of the survey to inform, educate and influence policy makers.

Minnesota NAHRO is gearing up for our annual Day at the Capital to be held on February 6, 2019. We will begin the day with education for our members followed by appointments at the capitol. Our staff is busy setting up meetings with legislative leaders for all participants.

A newly released initiative for MN NAHRO is the "members only" section of our website where we are featuring sample policies and forms. With the assistance of our Housing Committee, we also started sending out "hot topic" updates to our membership. These hot topics are sent monthly along with a member update. We are very excited to offer these two new member benefits.



Run Collaboration. Ron Clewer with the Alliance for Strong Families will be the keynote speaker. Adrianne Todman from NAHRO and Jennifer Keogh NCRC - President will be present to welcome everyone to Omaha. HUD will be providing Capital Fund/EPIC training and the HCV Two-Year tool training. Breakout sessions include "Shoppers Paradise – Wait List Shopping", "Living on Air – The Mystery of Zero Income", Section 8 Landlord Panel, Fraud & Ethics, VAWA and Transfer Requests, and Internal Controls. The Conference will also feature a "Health

& Housing" and "Disaster Planning" tracs. The conference budget was approved at the January board meeting in Chicago.

In 2018, NE NAHRO members received a free national training with their paid membership. Instead of a free training in 2019, NE NAHRO is offering members a \$200 stipend to help offset registration costs to attend the NCRC Spring Conference.

NE NAHRO has scheduled Procurement Training in Grand Island, NE March 12-14th. NIFA training has been scheduled for March 19-20th in Omaha. We will see you in Omaha in April.

OHAC is hosting a fourday Multi-family Housing Specialist Training by Nan McKay January 22 – 25, 2019 in Columbus, OH.

This training is in response to requests from our membership. It will include a section on the RAD conversions.

We are in the mist of planning the Annual Spring Conference to be held May 1-3, 2019 at The Summit, A Dolce Hotel in Cincinnati, Ohio. We anticipate the award of six scholarships at this conference. Training will include sessions on Managing Maintenance; a peer lead Best Practices for the Housing Choice Voucher Program; the good, the bad and the ugly of RAD (also peer lead); a HUD lead discussion on Section 18 and a Family Self Sufficiency session lead by Anice Schervish Chenault of HUD. In addition to this lineup we

are trying to coordinate with Ohio Public Employees Retirement System and Ohio Public Employees Deferred Compensation Program to provide sessions. We have hosted "HUD's PIC Room" in the past, this year we are expanding the concept to "Ask HUD": A Technical Assistance Room.

During the OHAC 2018 Fall Conference Luncheon, OHAC honored Hal Keller, President of Ohio Capital Corporation for Housing, as our first annual *OHAC Person of the Year*. The award was created to honor someone in the Affordable Housing arena that, is outside of OHAC, and has contributed to either the state, region or nationally. We are continuing to develop the criteria and deadlines for the award. It will be award at the Fall Conference each year.

We continue our advocacy at the state level. HB 336 Property Tax Valuations for Subsidized Properties was introduced in late November. This bill would require county auditors to value federally subsidized residential rental property based on its market rent without regard to government police powers or other governmental action. This bill, along with HB 282 Criminal Mischief Rental Restriction and HB 390 Eviction Timelines did not move in 2018. All three bills are expected to be reintroduced in this General Assembly.
