I very much wanted to bring this positive message for us, and even further to our whole membership. I appreciate Cheryl Anne's work to make that membership outreach possible, Jennifer Keough for her great ideas in how to finance the message, and Ron Clewer for generously providing sponsorship through Gorman and Company.

## **Recent Housing News:**

## **CARES Act Waivers Expire**

Many CARES ACT Waivers expired as of December 31<sup>st</sup>, 2021. HUD has provided two separate notices on the submission of waivers and closeout procedures for PHA's that took advantage of the waivers.

#### PHAS and SEMAP High Performer Bonus

On December 21<sup>st</sup> 2021 HUD provide a PIH Notice that states "For any PHAs with a fiscal year end on or before December 31, 2021, HUD will not issue a new PHAS score unless the PHA requests that a new PHAS score be issued."

HUD awards over 1 million for FYI HCV's On December 16<sup>th</sup>, HUD announced that it was awarding over 1 million to 26 PHS's in 20 states for its Foster Youth to Independence Initiative. Congrats to those who were awarded!

## HUD provides new guidance on Asset-**Repositioning Fee Eligibility**

This guidance covers all PHA's that are demolishing or disposing of public housing units.

#### **HCV Landlord Strategy Guidebook revisions**

A new chapter has been published titled "Landlord-Focused Customer Service" where it discusses landlord responsiveness, creating landlord single point of contact and creating a call center.

## Pending Congressional Bills:

## H.R. 3685 "Fair Chance at Housing Act of 2021" was introduced by Rep Alexandria Ocasio-Cortez of NY

This bill is to reform the screening and eviction policies for Federal Housing assistance in order to provide fair access to housing, and for other purposes. This bill was previously introduced in 2018 as well. This bill limits the authority of public housing agencies (PHAs) to deny or terminate federally assisted housing based on criminal conduct by the applicant or tenant. It is also being called "Last Chance at Housing Act"

## H.R. 5828 "Pets Belong With Families Act" was introduced by Rep. Adam Schiff of CA

This bill is to prohibit public housing agencies from imposing breed restrictions on household pets owned by residents of the dwelling units in public housing, and for other purposes.

## H.R 1904 "Broadband Justice Act of 2021" introduced by Rep. Jamaal Bowman of NY

To include broadband as a utility that tenants residing inn federally assisted housing can have subsidized by the Federal Government, and for other purposes.

## <u>PIH 2021-38 COVID-19 Statutory and Regulatory</u> <u>Amendment to PIH Notice 2021-14 (HA), Providing</u> <u>for the Release of Public Housing Assessment</u> <u>System Scores for Federal Fiscal Year 2019</u>

The Coronavirus Aid, Relief and Economic Security (CARES) Act (Public Law 116-136) provides the U.S. Department of Housing and Urban Development with broad authority to waive or establish alternative requirements for numerous statutory and regulatory requirements for the Public Housing program.

## <u>PIH 2021-37 Guidance on Eligibility for Asset-</u> <u>Repositioning Fee (ARF)</u>

This notice applies to all public housing agencies and authorities (PHAs) administering Public Housing, including Moving to Work (MTW) PHAs with Alternative Operating Subsidy (AOS) formulas that allow for the receipt of transition funding.

## PIH 2021-36 CARES Act Supplemental Operating Fund Close-Out Procedures

This Notice provides information on the following topics related to the end of the period of performance of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (Public Law 116-136).

## <u>PIH 2021-35 Guidance on Inventory Management</u> <u>System/PIH Information Center (IMS-PIC) Sub-</u> <u>Module Reporting and Validation</u>

The purpose of the guidance in this notice is to ensure that Public Housing Agencies (PHAs) maintain and submit accurate, timely, and reliable unit designations in the IMS-PIC Development Sub-Module.

**PIH2021-34 Expedited Regulatory Waivers for the Public Housing and Housing Choice Voucher (including Mainstream and Mod Rehab) Programs** This Notice advises PHAs that they may apply for certain regulatory waivers that were originally offered as part of the CARES Act waivers in Notice PIH 2021-14 to provide continued flexibility during the pandemic and pandemic recovery.

## PIH 2021-33 Submitting CARES Act Waiver Adoption Information to HUD by December 20, 2021

This guidance provides directions to Public Housing Agencies (PHAs) on the required reporting in the CARES Act Waiver Reporting Tool (CAWRT)

## PIH 2021-32 EXTENSION of American Rescue Plan Act – Adjustment Funding for Calendar Year 2021 Housing Choice Voucher Program and Mainstream Vouchers Renewal Funding Applications

This notice announces that HUD is extending the application deadline for CY 2021 renewal adjustment funding for PHAs that experienced a significant increase in voucher per-unit costs (PUC) due to extraordinary circumstances from the previous due date of August 10, 2021, to the new due date of 5 p.m., per the PHA's time zone, Wednesday, December 21, 2021.

## <u>PIH 2021-31</u> <u>Public Housing Operating Subsidy</u> <u>Grant Eligibility Calculations and Processing for</u> <u>Calendar Year (CY) 2022</u>

This notice provides public housing agencies (PHAs) with instructions for calculating Operating Subsidy grants for CY 2022 and establishes submission dead-lines.

## <u>PIH 2021-30 Revision of Application Process for</u> the Small-Rural Frozen Rolling Base Program

This Notice provides updated guidance to Public Housing Agencies (PHAs) on the implementation of Section 209 (b) of the Economic Growth, Regulatory Relief, and Consumer Protection Act (Economic Growth Act), Public Law No: 115-174.

## <u>PIH 2021-29 Supplemental Guidance to the Interim</u> <u>Final Rule "Extension of Time and Required</u> <u>Disclosures for Notification of Nonpayment of</u> <u>Rent"</u>

This Notice's purpose is to provide supplemental guidance to implement the requirements included in the Interim Final Rule titled "Extension of Time and Required Disclosures for Notification of Nonpayment of Rent." This notice also serves as the required determination by the Secretary of the Department of Housing and Urban Development that the existence of a national emergency necessitates the activation of the required minimum 30-day notification period and other required actions to support families at-risk of eviction for non-payment of rent.

#### <u>PIH 2021-28 Providing Interim Funding to</u> <u>Recipients of Indian Housing Block Grants</u>

This notice supersedes PIH Notice 2013-29. This notice provides updated information to Indian tribes and tribally designated housing entities (TDHEs) on the process for requesting an advance on Indian Housing Block Grant (IHBG) formula funds, or interim funding, while under a Continuing Resolution (CR).

## <u>PIH 2021-27 Updates to Flat Rent Submission</u> <u>Requirements</u>

This Notice supersedes and replaces the guidance provided in Notice PIH 2017-23, clarifies HUD's interpretation of the statutory amendment related to flat rents, and updates flat rent exception and extension request requirements, including review criteria for HUD Form 5880.

## 2021 NAHRO Online National Conference & Exhibition

The NAHRO Online National Conference & Exhibition took place October 7<sup>th</sup> and 8<sup>th</sup> of 2021. The Plenary Session was addressed by HUD Secretary Marcia L. Fudge. Although we very much would have loved to come out and spend time with our fellow housing and redevelopment colleagues in person, it was in the best interest of everyone's health and safety to meet virtually due to the pandemic. Hopefully, things will get better and turnaround in 2022 and allow us to finally meet in person for the 2022 National Conference & Exhibition, September 22-24 in San Diego, CA and maybe even the 2022 Washington Conference, March 28-30 in Washington, DC. The sessions topics included dedicated tracks for:

- Public housing
- Community development
- The Rental Assistance Demonstration (RAD) program
- Organizational management; and
- Commissioners

## **Reducing Land Use & Zoning Restrictions**

On Friday, October 29th, the White House invited the public to attend a virtual webinar, a first in a series, on overcoming supply constraints in the housing market. This first event focused on how reducing land use and zoning restrictions can help to expand housing supply. Shortages in housing stock and their associated social and economic consequences have been an increasing issue for quite some time and many of the regulations that artificially limit housing supply exist at the state and local levels. President Biden's Build Back Better Act proposed critical investments that would produce or preserve millions of affordable housing units. Let's see what 2022 holds for the future of this Act in the Senate, but let's all tell Congress to support the \$150 billion in housing in the Build Back Better Act.

HUD Publishes Expedited Waiver Notice for Public Housing and Voucher Programs

On Dec. 9, HUD published a notice titled "Expedited Regulatory Waivers for the Public Housing and Housing Choice Voucher (including Mainstream and Mod Rehab) Programs" (Notice PIH 2021-34). The COVID-19 waivers for the public housing and voucher programs were published because of authority given to HUD through the passage of the Coronavirus Aid, Relief, and Economic Security (CARES) Act. Additional information on the expiration of these waivers can be found in HUD's guidance for winding down CARES Act waivers; PIH 2021-14 (providing revised waivers for public housing and the HCV program); PIH 2020-20 (providing waivers for the Mod. Rehab. program); and PIH 2020-22 (providing waivers for Mainstream vouchers).

Finally, I would like to wish all of the members of NCRC a happy, prosperous, healthy and safe New Year and continued success as we journey forward into 2022!

## **Member Services Committee**

As of the national NAHRO Transition Report from 2019-2021 membership consisted of almost 2,700 agencies,

community development agencies, non and for profit organization of which per the most recent NCRC membership report, 991 were from our region roughly 37%.

At the national level the Member Services Committee has been involved in a number of strategic initiatives to include:

- Membership Dues
- Strategic Planning
- Awards
- Recruitment, retention, and advocacy

For the Regional level, as I understand it there is not an "active" committee, however this would be one of my main initial goals I would suggest to the President and Board, to start and create an active committee, to move forward local, regional, and national goals.

Secondly, engaging the current membership to ensure we retain current membership, while determining the reasons for non renewal in order to strategically ensure we engage our current members and bring new membership at the Regional level.

In closing, as a high representative number of membership in the NCRC level within NAHRO, the NCRC Member Services Committee, should continue to represent this region at the National level, but should also establish at the Regional level, a viable and meaningful committee, work with the President and board to establish some goals, while engaging current membership.



I am grateful for the opportunity to be serving as the NCRC Small Agency Advisory Committee Chair for the 2021-2023 term and excited to connect with others who

share the same dedication. NAHRO's Small Agency Advisory Committee met on January 15<sup>th</sup> to listen and discuss issues of concern to small agencies. Attendees were joined by NAHRO President Patricia Wells and SeniorVice President George Guy, along with NAHRO Staff who discussed HUD updates, Capitol Hill, Small Agencies Resource Library and 2021-2023 Term Goals.

NAHRO Chairman of the Small Agency Advisory Committee, David Gates discussed the importance of networking and connecting with colleagues at the local level and how that can be best accomplished. Our agencies may be small, but we represent a large segment of NAHRO, andwe need to get our voices and

concerns addressed. The 2021-2023 Term Goals will be focused on Member Experience, Preparing New Leadership, Fee Structuring, Advocacy and Small Agency Involvement.

Marty Ryan discussed the proposed small agency resource library. Agencies would have access to forms, policies etc. that have been shared. Current list of items that will be included in the resource library are available, if you are interested in that list or if you would like to suggest additional categories to be included, please contact Marty Ryan or myself. Further updates will be provided when this resource is live and available for agencies.

Interim Director of Policy & Program Development, Eric Oberdorfer, discussed the CARES Act Waiver Reporting Tool (CAWRT) <u>CARES Act Waiver</u> <u>Reporting Tool (CAWRT) (Page 1 of 10) (office.</u> <u>com</u>). All PHAs are required to enter information into the CAWRT, including those that did not adopt discretionary COVID-19 waivers. This information is being gathered so that HUD may determine which waivers were beneficial and which may be utilized to relieve administrative and regulatory burdens in the future.

Additionally, HUD <u>Notice PIH 2021-34</u> advises PHAs that they may apply for certain regulatory waivers that were originally offered as part of the CARES Act waivers in Notice PIH 2021-14 to provide continued flexibility during the pandemic and pandemic recovery. The requests must be received by HUD before March 1, 2022, to receive expedited processing. In requesting one of these waivers for expedited processing, a PHA must show "good cause." Regulatory waivers eligible for expedited review include: Increase in Payment Standard During HAP Contract Term, SEMAP Score, Term of Voucher, Homeownership: Maximum Term of Assistance and Voucher Tenancy: New Payment Standard Amount.

On Jan. 18, HUD sent a letter to PHA Executive Directors titled "<u>CY 2022 Housing Choice Voucher Program (HCV)</u> <u>Renewal Awards</u>." The letter provides information on current and future prorations of voucher accounts to help HCV program administrators in planning their program. The letter notes that the federal government is operating under a continuing resolution (CR), which will fund federal programs (including the HCV program)

at the same rate as last year until Feb. 18, 2022. Under this CR, the HCV housing assistance payment (HAP) proration will be 98.5% for Jan. and Feb. Similarly, under this CR, the HCV administrative fee proration will be 84% for Jan. and Feb. Mainstream vouchers will receive the same prorations for its HAP and administrative fee accounts respectively. At this time, PHAs may anticipate HAP and administrative payments for Feb. Draft appropriations bill for CY 2022. The estimate for the House bill is 90% for the administrative fee and full funding for HAP. The

estimate for the Senatebill is 93% for administrative fee and full funding for HAP.

Director of Congressional Relations Tess Hembree provided an update regarding the current concerns with affordable housing being included in the Build Back Better Act. Housing affordability is a crisis right now and it needs to be addressed. Advocacy continues to play an important role to ensure affordable housing is included in the bill. Please take the time to join and support to the Build Back Better Act: Housing Sign-On Letter at <u>Build Back Better Act</u>: Housing Sign-On Letter (google.com).

The NCRC Small Agency Advisory Committee met on February 3, 2022, via zoom, it was very nice to meet everyone. Some of the items we discussed included HCV landlord retention and recruitment, lack of resources available to smaller agencies, especially in support of mental health and elderly resident needs. Please reach out to your state representatives for more information.

## Legislative Report Chris Lamberty, NCRC Legislative Chair

The Legislative Network Committee (LegNet)convened on December 15, 2021, to discuss the status

of Build Back Better, FY22 funding and next steps. Jennifer Keogh, Chair, and Tess Hembre, NAHRO staff, provide the organization excellent leadership.

- 1. Build Back Better. The House passed a BBB bill in November with \$150 billion in additional housing funding, including a substantial infusion to the Capital Fund. The Senate democrats have been unable to agree on a way forward and have not yet voted on the House version or any other version. Going into the holidays they did not have the votes to advance a bill and the prospects looked grim. It is unclear at this point if they will attempt to break it up into smaller funding pieces or continue negotiating for a reduced BBB bill. The housing funding does not appear to be one of the controversial or problem areas in the bill, but it could still get lost in any repackaging of the funding bill or bills. It is imperative for NAHRO members to continue to contact their congressional representatives and make sure they know that housing funding is a priority. It is easy to send letters through NAHRO's Action Alert Center at <u>www.NAHRO.org</u>. NAHRO staff will continue to push information out as the Senate comes back in the new year. Be prepared to act fast.
- 2. Fiscal Year 2022 Funding. With all the attention on Build Back Better, there has been little movement on FY22 funding appropriations. The federal government is currently operating at last year's funding levels under a Continuing Resolution through February 18, 2022. Congress will need to pass final appropriations or another Continuing Resolution by then. At this point there is a realistic possibility that we could see a CR for the full year. NAHRO members will need to advocate for covering increased voucher program costs if that is the way Congress is headed.
- 3. Congressional District Contacts. NAHRO has been building a network of contacts in every Congressional District in the country and will be looking to fill or replace CD Contacts in the new year. The ask is simple: Pledge to send action alerts to your members of Congress, and NAHRO will directly alert you to new letters in the Action Alert Center. Your participation will help us target Congress members who can support vital housing and community development legislation. Your NCRC LegNet representatives will be working to recruit you to help in our region. Save us time by volunteering now! If you are interested send me an email at Chris@L-housing.com.

Irma Gorham, PHM Executive Director of the Housing Authority of the City of Paterson is the Chair of the National Standing Committee that includes active participation from the North Central Region Council.

On a meeting held on December 10, 2021, the different sub-committees have been established:

**Research:** This sub-committee is tasked with the development and investigation of selected topic(s) as described in the plan. The committee would determine appropriate methods of research and investigation using a variety of tools and engaging with stakeholders, key informants, and partners. The committee would also oversee research projects and then work with NAHRO to disseminate the results of that research to the membership through presentations and articles.

## How to Improve Your Housing Organization's Online Reputation [90-Day Action Plan]

Online reputation management is more crucial than ever in maintaining a successful multifamily operation. In terms of attracting potential residents, building a positive online reputation can be a gamechanger because most consumers search online to find local businesses and services.

That hasn't always been the case, said Lia Smith, senior vice president of <u>ApartmentRatings</u> and <u>Sati</u> <u>sFacts.</u>

Until 2019, regular surveys conducted by SatisFacts—a provider of resident surveys focusing on multifamily retention and reputation management—showed that referrals from family and friends were the most crucial step in the renting process. But in 2019, online reviews took over. Then the pandemic took hold in 2020, pushing the online trend even further.

"Everyone's jumping behind their computers," Smith said, noting that the trend isn't exclusive to the multifamily industry. "You're getting behind the computer and trying to gather as much information as you possibly can, which is what's happening when someone is looking for an apartment."

## The four-step apartment search cycle

Let's say you attract new renters online; in the future, they may leave a review about their experience in your community, potentially attracting (or scaring away) prospects. Here's the apartment search cycle breakdown:

• Stimulus: The point at which renters know you exist

In this phase, prospects are using generic search terms to find living arrangements (e.g., apartments in Louisville; two-bedroom apartments in Louisville; apartments in Louisville close to school).

"Very rarely is someone going to get behind their computer and type in a specific community's name.," Smith said.

It's similar to how most of us search for a car, she explained. First, you search for the model you like;

then, you find a dealer.

• Zero Moment of Truth (ZMOT): The initial research phase

The options are now narrowed down based on generic search results. Smith said that prospects are looking at a specific community's website or apartment listing. They're looking at photos, checking out social media pages, and reading online ratings and reviews.

• First Moment of Truth (FMOT): Validating research results

At this point, prospects are now looking to visit specific communities virtually or in-person to verify whether the information they found online is accurate.

"We call this living up to the online hype," Smith said.

When the amenities prospects see during their online search align with what they see in person, "that's when people feel confident to say yes," she noted.

• Second Moment of Truth (SMOT): Sharing the overall experience

In the final stage, the prospect has become a resident. They now have regular interactions with staff and neighbors, for example.

They now have something to say about your community, whether positive or negative. When they post that experience online, the review directly impacts a prospect's ZMOT phase.

"It all works in a big cycle," Smith said.

## Social proof and wisdom of the crowd are vital for reputation

Ratings and reviews serve as *social proof* during the ZMOT phase. *Social proof* is like a collective thumbs up or thumbs down.

"It acts like adult peer pressure," Smith said of *social proof*. "If enough people are talking about it, the *social proof* pushes someone in a certain direction."

Wisdom of the crowd isn't as broad as social proof;

it applies to the actual feedback (what's written in the review) and is more critical during the SMOT phase. A review with a 1-star rating that says a rental application was denied is subjective and doesn't apply to every prospect. The community's *social proof* might still be overwhelmingly positive.

*Wisdom of the crowd* doesn't always have the power to sway prospects unless multiple reviews portray the same sentiment.

"If there are resounding echoes, over and over again, that's how you know that it's not just about the star rating," Smith said. "The *wisdom of the crowd* is saying something else."

When considering a community's reputation, you have to look at *social proof* and *wisdom of the crowd* as bookends, Smith added.

## Data says review star ratings and legitimacy matter most to rental prospects

Quantity doesn't mean quality when it comes to reviews. A <u>recent consumer study</u> from BrightLocal found star ratings are the most important factor for consumers when considering a business or service.

You might think a perfect 5-star rating is a driving force behind a positive reputation, but <u>the study</u> found that 88 percent of consumers don't need a 5-star rating to buy from or work with a company. A 5-star rating can come across as insincere to prospects, Smith said. A star rating between 4 and 4.5 "gets the most action in terms of generating leads," she added, citing the BrightLocal study and internal metrics from ApartmentRatings.

Not surprisingly, a star rating below 4 isn't ideal. The BrightLocal study found only 48 percent of consumers would consider a business with fewer than 4 stars—that's half of the potential customers searching online.

Behind star ratings, legitimacy is the most critical factor in a review. Prospects prefer honest, authentic reviews from someone with first-hand knowledge of the property.

"A bunch of dishonest 5-star reviews from employees and management can work against you," Smith said.

More credibility is given to recent reviews. Prospects want to know what residents are thinking about the current state of the community, Smith said.

The <u>BrightLocal study</u> found 86 percent of consumers say they only look at reviews from the past three

months, while 73 percent say reviews must be from the last month to influence their choice.

"In this business, there's so much change that happens," Smith said. "The person who wrote review six months ago might not live in the community. You want to capture new content and new reviews."

Review sentiment (a prospect's reading of *wisdom of the crowd*) is the fourth most important aspect of reviews, followed by the quantity, according to the BrightLocal study. Smith advises that communities and management companies focus on soliciting quality, first-hand reviews from current residents rather than getting as many reviews as possible.

## Avoid incentivized and deceptive reviews

Incentivized and deceptive reviews can hurt a community's reputation and wallet. The Federal Trade Commission (FTC) protects consumers from shady business practices. Deceptive and fake reviews can lead to consumer complaints and FTC enforcement against a business. If a business is using misleading and fake reviews, the FTC can levy fines, and the agency can place it under close monitoring for up to 20 years, Smith said.

• Incentivized reviews

Incentivized reviews are allowed by the FTC (e.g., residents rewarded with prizes, gift cards, rent credits, apartment upgrades, etc.), but the incentive must be disclosed inside the body of the review. For example, if a resident is asked to leave a review in return for \$50, they must disclose the compensation they received in the review. According to Smith, the disclosure of an incentive may cause prospects to write off the review as disingenuous.

"Especially if the review is positive," she said. "Because what are the chances someone is going to leave you a 1-star review if they think it's going to jeopardize their opportunity to get a gift card, or reward points, or rent credit?"

If a resident forgets to disclose the incentive, the responsibility falls back on the community or management company to act or risk FTC enforcement. A response must be posted to the review that clarifies that it was published as part of an incentive program.

"But once that's exposed, it's going to negate the credibility of that review," Smith said. "And that review could be 100 percent honest. We recommend no incentives—none whatsoever."

Deceptive reviews

It's not illegal for a property's employee or contractor to leave a review, but they must disclose their relationship to the property, similar to incentivized reviews. If not, it's considered deceptive by regulators.

Another deceptive practice in the eyes of the FTC is review gating, Smith said. An example of review gating would be if you leave a 5-star review for a business and you're asked via a follow-up email to leave comments. The positive comment is automatically posted as an online review on a company site or rating page.

If you left a 1-star review, you would receive the same follow-up email asking for your thoughts. But instead of posting a negative comment as an online review, you're redirected to the company's support team to attempt to fix the issue.

"You're never given a chance to write a negative review," Smith said of review gating. "If negative comments don't immediately get turned into an online review as with the positive, that's review gating, and you want to run away from that. It's a big no-no in the eyes of the FTC."

Suppose a deceptive or improperly incentivized review is found on a company page. In that case, the responsibility falls on the company to remove the review or include a consumer alert that discloses the violation.

#### Adhere to the Consumer Review Fairness Act

The <u>Consumer Review Fairness Act</u>, signed into law in 2016, bans gag clauses to prevent negative reviews.

"You cannot prevent someone from writing a negative review, and you can't retaliate against someone who writes a negative review," Smith said of the law.

Businesses are not allowed to include standardized provisions that threaten or penalize people for posting honest reviews.

"You can't fine or charge someone for posting a negative review," she added.

The law doesn't mean communities and property managers are powerless in dealing with negative reviews posted out of retaliation.

Smith said that retaliatory reviews are reportable. Most review sites provide options to report or flag retaliatory reviews, especially if the same review is posted on multiple websites.

## Negative reviews make your positive reviews shine

"Negative reviews, I call them your best friend," Smith said.

Based on her experience, a limited number of negative reviews can increase credibility.

"Readers already know why they want to live in a community based on the photos, floor plans, and pricing," Smith explained. "They're reading the negative reviews for the why not."

The "why not" doesn't apply to every prospect; take a reviewer that complains about children making noise. If you have children, that might not deter you from moving in.

"You can have a couple of negative reviews, and if they're each talking about something different, it's not the *wisdom of the crowd* necessarily, so this won't impact someone else's decision," Smith said. "If all reviews are positive, it brings about skepticism. Negative reviews make your positive reviews shine."

#### Always respond to reviews (quickly!)

No matter the review's sentiment, prospects want to see <u>that the business cares</u>: 69 percent of consumers are more likely to use a business that responds to their positive reviews, while 70 percent are more likely to use a business that responds to negative reviews.

"Management companies, teams on-site, they do care about their residents," Smith said. "A majority of us aren't just punching the clock—we don't want to sabotage that by note responding to a review."

If a review is in a different language, always translate the response to that language. If the review is anonymous but based on context, it's clear who the resident is, don't call the resident out.

"That's seen as retaliatory," Smith said. "You never know when it can open the door to a fair housing complaint."

Don't use "corporate speak" in response, such as lease language, she added. In terms of timing, Smith advised responding to positive reviews within 48 hours and negative reviews on the same day (within 24 hours).

#### Negative review response tips

Show the steps being taken to address the issue(s). Speak to the person reading the review, not the actual review, who has already given their opinion. Based on the response, readers will see that the business cares about customer service, Smith said. Use singular pronouns such as 'I' and 'me' when responding to negative reviews. This provides a personal touch, she added.

• Positive review response tips

Demonstrate gratitude for the positive feedback. Respond directly to the reviewer, not the reader (though the reader is still looking at the response). Use plural pronouns such as 'we' or 'us' when responding to positive reviews.

## Keep review vendors on brand

Some businesses outsource review responses and monitoring to a third-party vendor. This can be beneficial to communities short on staff and time, but there are some things to watch.

"Make sure you have full oversight of your content," Smith said. "If a violation occurs, the onus is on your company and not on the review vendor."

Avoid vendors that use templates or bots to respond. Review responses should be custom and personalized. Ensure the provider is responding to reviews promptly, Smith said.

## The 90-day reputation management plan

Smith said this simple 90-day plan will help around a community's reputation.

Day 1-30

Search for the community online and see what people are saying. Get a sense of the social proof around the community. Is it positive or negative? Gather feedback from existing residents. Respond to any unanswered reviews.

• Day 31-60

Implement new strategies and processes based on the top concerns from residents (e.g., parking, landscaping, rent payment process, etc.). Outline goals and a plan to achieve those goals. Monitor progress and employee performance.

• Day 61-90

Now that you've made improvements based on resident suggestions, cultivate gratitude by asking those same residents to provide feedback. If their concerns are being addressed, the feedback will likely be positive. Look at pain points and what's going well, and plan to minimize the negative while amplifying the positive.

NE-NAHRO is planned to resume in-person meetings beginning in February 2022. Our next scheduled Board Meeting will take place on February 11,

2022. The South Sioux City Housing Agency has graciously accepted to host our NE-NAHRO 2022 Fall Conference scheduled for September 20<sup>th</sup>-22<sup>nd</sup>, 2022. Our conference committee is diligently planning the conference as we will be celebrating our 45<sup>th</sup> anniversary. In addition to our regular meetings and conferences, NE-NAHRO hosts a variety of in-person and webinar trainings through the year including commissioner fundamentals and ethics, rent calculations, fair housing, etc.

The state chapter began its 2022 membership drive. We continue to make a bolstered effort to increase our membership. Being Nebraska has over 100 housing agencies and many executive personnel staffing changes, we plan to begin providing "Welcome Packets" as agencies hire new Executive Directors to provide them support and engage them with our chapter. Approximately 102 housing agencies are currently in our membership!

The state chapter has implemented a scholarship program for graduating seniors and non-traditional students who are preparing to enter college or secondary education as a part-time (less than 12 credit hours) or full-time (12 credit hours or more) student. Students must reside at a Nebraska NAHRO member housing agency to be eligible.



NATIONAL ASSOCIATION OF HOUSING AND REDEVELOPMENT OFFICIALS

The scholarship fund will be administered by the Nebraska NAHRO schol-

arship committee and will offer a \$1,000.00 (for full-time student) or \$500.00 (for part-time student) scholarship to be paid for the Fall semester. The student will need to reapply each year for a continuation of the scholarship. The funds will go directly to the school that the student will be attending. The school will deposit the funds in the student's account. The funds may only be used to pay for tuition, books, and activities directly related to the student's education.

The second year of the two-year session has started for the Nebraska Legislature. Last year, NE- NAHRO supported LB 412 to expand property tax exemptions to property owned in partnership with PHAs. The Revenue Committee killed that bill. After several conversations with Senator Bostar's office about introducing the bill again, it was determined that the best strategy would be to wait and introduce it next year to a new Revenue Committee.

A priority for the Legislature this year will be to allocate \$1 Billion in new federal funding. Through the first four days of bill introductions, one bill (LB 940) has been introduced to allocate \$200 million of those funds to housing programs -\$50 million to Rural Workforce Housing, \$50 million to Urban Workforce Housing, \$50 million to the Affordable Housing Trust Fund, and \$50 million to NIFA programs. More news to come on that front.
